Based on a thorough survey, the National Child Exploitation Threat Assessment for 2016 primarily focuses on changes to the threat of child sexual exploitation as wellas other risks that are harmful for children¹⁷.

The five illegal activities listed below that are connected to the exploitation of children are given priority in the threat assessment: (1) child pornography; (2) "sextortion" and the live
