increased demand for dowry after marriage and harassment for non fulfillment of such demands and dp act apart from which he had to file a complaint case under section 12 of The domestic violence act 2005. The matter is pending in moradabad court. then the father of the applicant was shifted to jhansi.

He had retired from his service and settled in jhansi which is his native place. Haven't come yet. In all three cases the guests have to face great inconvenience in coming from jhansi to moradabad. The opposition parties are residents of delhi and they will be equally comfortable traveling from delhi to moradabad instead of delhi to jhansi. Trains between delhi and jhansi have good frequency that all three cases are not transferred from moradabad to jhansi. The transfer of the case from moradabad to Jhansi. The transfer of the case from Moradabad to Jhansi Is not is not likely to cause any hardship to the opposite parties.

Gave every thing in dowry. In the said case also, the greedy of dowry forced another woman to commit suicide due to the greed of dowry. Even after receiving very thing in dowry, his desire to get more did not end. His constant thrashing to harass riya priya committed suicide by hanging herself from the fan due to mental and physical torture. The woman must have been troubled both financially and mentally in this, only then she was forced to take this step. Ironically, his father filed a case for justice twice.

First in jaunpur court and second in varanasi court in which section 498 a 504 506 was filed under ipc. In which a case was also registered against the in laws of the deceased under section 120 of the domestic violence act only 801 of 2017 is pending. Whatever arguments have been presented before his court by the learned counsel for the applicant in that case.

Whatever arguments were presented before this court by the learned counsel for the applicant in the said case, they can be taken up before the trial court and, if advised, they can also be demanded at the appropriate level.
